

# Skills Assessment Pilots

The Australian Government has introduced three Skills Assessment Pilots to provide greater opportunities for onshore migrants to join the workforce and address skills shortages.

Pilot 1 – Faster Migrant Skills Assessments (concluded in June 2022).

Pilot 2 – Skills Assessment Opportunities for Migrants (open and accepting applications until 29 February 2024)

Pilot 3 – Employability Assessments (open and accepting applications).

## Pilot 2 – Skills Assessment Opportunities for Migrants

AITSL can offer free and fast-tracked assessments of the skills and qualifications of skilled migrants who are ready to commence skilled employment as teachers in the following occupations:

- Early Childhood (Pre-primary School) Teacher (ANZSCO 241111)
- Primary School Teacher (ANZSCO 241213)
- Secondary School Teacher (ANZSCO 241411)
- Special Needs Teacher (ANZSCO 241511)
- Teacher of the Hearing Impaired (ANZSCO 241512)
- Teacher of the Sight Impaired (ANZSCO 241513)
- Special Education Teachers (nec) (ANZSCO 241599)

Having your skills assessed as suitable for Australian workplaces will improve chances of getting a job. Businesses and employers will have the confidence that you have the skills they need to do the job.

**Please note that this assessment is for employment and not migration purposes. The steps for a skills assessment for migration are outlined [here](#).**

### Am I eligible?

To be eligible to apply, you must:

- have skills, experience and/or qualifications in an [eligible occupation](#)
- not have received a skills assessment in the occupation
- be currently residing in Australia

- hold an eligible family, partner, humanitarian or refugee [visa, or is a secondary entrant to a skilled visa holder](#)
- have held that visa from 1 January 2016.

## Other information

### How long will it take?

It should take about 15 business days to complete your assessment once we have received all the information required from you.

## Pilot 3 – Employability Assessments

Pilot 3 offers a free employability assessment and access to subsidised training for migrants who have already received a suitable skills assessment outcome as a teacher but are currently working below this skill level in the following occupations:

- Early Childhood (Pre-primary School) Teacher (ANZSCO 241111)
- Primary School Teacher (ANZSCO 241213)
- Secondary School Teacher (ANZSCO 241411)
- Special Needs Teacher (ANZSCO 241511)
- Teacher of the Hearing Impaired (ANZSCO 241512)
- Teacher of the Sight Impaired (ANZSCO 241513)
- Special Education Teachers (nec) (ANZSCO 241599)

## Am I eligible?

To be eligible to apply, you must:

- have received a suitable skills assessment outcome on, or after 1 April 2019 from AITSL and have held the suitable skills assessment outcome for at least 12 months
- be seeking an Employability assessment in the [occupation](#) for which you received a suitable skills assessment
- be in paid employment below your skill level. For example, working as an early childhood carer when you were found suitable as an Early Childhood Teacher or as a Teacher Assistant when you were found suitable as a Primary teacher
- have worked a minimum of 30 hours per fortnight within the last month (can be a mix of paid and study and/or volunteer and/or internship work and can be with more than one employer)
- be currently residing in Australia
- hold an eligible [permanent visa subclass](#)
- not be registered as job seeker or have an active referral with Workforce Australia, Disability Employment Services or the Community Development Program
- have not previously completed or withdrawn from a Pilot 3 assessment.
